



**Position Title:** Watercraft Inspector, Lower Long Lake, Chippewa County

**Hourly rate of pay:** \$11.00 per hour with completion bonus at end of season

**Length of position:** May 20<sup>th</sup>, 2019 through Labor Day, 2019.

**Work Schedule:** 16 hours/week with additional hours over holiday weekends. Weekend and holiday work required.

Weekly schedule Saturday and Sunday 8:00am – 4:00pm.

Holiday schedule will include:

Memorial Day, 4<sup>th</sup> of July, and Labor Day.

Total hours not to exceed 232.

**Location:** Based at Lower Long Lake located north of Bloomer in Chippewa County with occasional travel to Beaver Creek Reserve located in Fall Creek, WI.

**Position Description:** Beaver Creek Reserve Citizen Science Center is seeking an enthusiastic intern to assist with aquatic invasive species (AIS) prevention and education. The main duties of a Watercraft Inspector are to increase awareness of AIS by sharing information, laws and prevention steps with boaters, anglers and boat landing visitors. Inspectors help individuals check their watercraft and equipment for aquatic plants and animals before they enter and upon leaving the water.

**Background:** Aquatic invasive species have the potential to negatively affect our ecosystems, economy and recreational opportunities. With over 15,000 lakes and 5.3 million acres of wetlands, Wisconsin waters are an extremely valuable natural resource. As a Watercraft Inspector, you will aid the state's invasive species prevention efforts, thereby playing an important role in preserving Wisconsin's water bodies for future generations.

**Primary Responsibilities:**

- Successfully complete a Clean Boats, Clean Waters training session.
- Disseminate information to boat landing visitors on AIS and prevention.
- Conduct watercraft inspections, record data and report the data in an online database.
- Participate in statewide education strategies including Draining Campaign and Landing Blitz.
- Keep in regular contact with Lower Long Lake Protection and Rehabilitation District.
- Meet regularly with supervisor to discuss and review inspection schedule.

**Required Qualifications:**

- Be at least 18 years of age with a valid driver's license. Use of personal vehicle required.
- Be willing and able to approach, engage and educate diverse citizens at boat landings to encourage a change in behavior and instill a sense of personal responsibility to prevent spread of AIS.
- Have good verbal and written communication skills to communicate with a variety of audiences, including boaters, the media, and various user groups.
- Be able and willing to work outdoors in variable weather conditions.
- Be well-organized, self-motivated, able to multi-task, and able to work independently.

**Preferred Qualifications:**

- Have a good working knowledge of aquatic ecology, of the impacts that aquatic invasive species can have on lakes, streams and wetlands, and of the ways to reduce the spread of aquatic invasive species.
- Be skilled at identification of aquatic plants and animals and be able to work with experts in the state and region.
- Natural Resources, Education, or related class and/or work experience preferred.
